



A BILL FOR AN ACT

To appropriate the sum Three Thousand Seven Hundred Fifty Three Dollars (\$3,753.00) from the Lelu Town Treasury to supplement the Personnel Cost of the Executive and Legislative Branches of the Lelu Town Government for period ending September 30, 2020, and for other related purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1: Purpose.** The purpose and intent of this act is stated clearly in its title.
2. **SECTION 2: Appropriation.** The sum of three thousand seven hundred fifty three
3. dollars (\$3,753.00) is hereby authorized and appropriated to supplement the Operation
4. of the Lelu Town Government.
5. **SECTION 3: Apportionment.** The sum appropriated by this act shall be apportioned as
6. follows:

7. a) Executive Branch	\$ 3,617.00
8. a) Personnel	\$3,617.00
9. b) Legislative Branch	\$ 136.00
10. b) Personnel	\$136.00
11. **SECTION 4: Management.** The sum appropriated by this Act shall managed and
12. administered by the Mayor and shall be accounted for in accordance with the Lelu
13. Town Ordinances and applicable rules. The Mayor shall be responsible for ensuring
14. the sum appropriated is used for the purpose for which is appropriated and that no
15. obligations are incurred excess of the appropriation.
