A BILL FOR AN ACT

Relating to creation and establishment of the Lelu Water Council for the Lelu Town Government and for other purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. SECTION 1. Purpose. The purpose is to effect the initial creation and
2. establishment of the Water Council (LWC) for the Lelu Town
3. Government. The purpose is also to meet the provisions under
4. environment sector of the 2020 working document.
5. SECTION 2. Establishment and Composition. It is hereby established
6. the Lelu Water Council under the Mayor's office to support the
7. general welfare of the people of Lelu Municipality. The LWC shall
8. comprised of six (6) members representing each hamlet of Lelu. It
9. shall be a duty of the Mayor to nominate members of the LWC and
10. transmit to Lelu Town Council who in turn consenting resolutions
11. shall confirm nominees by two third vote. Any nominee not
12. confirmed shall be returned to the Mayor for replacement.
13. SECTION 3. Removal Authority. The members of the LWC will serve
14. at a pleasure of the Mayor and the Council. Any member shall be
15. removed if the Mayor and two-thirds of the council approved.
16. SECTION 4. Effective Date. This Act shall become effective upon
17. approval by the Mayor or upon its becoming an ordinance without






