





**A BILL FOR AN ACT**

To appropriate the sum of \$4,000.00 (Four Thousand Dollars only) from the Lelu Town Government General Treasury to fund all related costs accumulated during this year's Liberation Day festivities and for other purposes.

**BE IT ENACTED BY THE 12<sup>TH</sup> LELU TOWN COUNCIL:**

1. **SECTION 1. PURPOSE:** The purpose and intent of this bill is stated
2. clearly in its title.
3. **SECTION 2. APPROPRIATION:** The sum of \$4,000.00 is hereby
4. authorized and appropriated from the Lelu Town Treasury to fund
5. all expenses related to the observance of the 2022 Liberation
6. Festivities.
7. **SECTION 3. APPORTIONMENT:** The sum appropriated in Section 2 of
8. this Act shall be apportioned and disbursed as follows:
  9. a. Farming and Fishing \$4,000.00
10. **SECTION 4. MANAGEMNET:** The sum appropriated by this Act shall
11. be managed and administered by the Mayor of Lelu and shall be
12. accounted for in accordance with the Lelu Town Ordinances and
13. applicable rules. The Mayor shall be responsible for ensuring
14. the sum appropriated is used solely for the purpose for which
15. is apportioned and that no obligations are incurred in excess
16. of the appropriation.

17. **SECTION 5. LAPSE DATE:** The sum authorized and appropriated by  
18. this Act shall be lapsed on September 30, 2022. Any unobligated

21. **SECTION 6. EFFECTIVE DATE:** This Act shall become an ordinance  
22. upon the approval by the Mayor or upon its becoming an ordinance  
23. without such signature.


