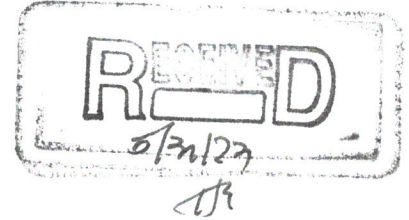
Dear Acting Mayor Nedlic,

A BILL FOR AN ACT

To appropriate the sum of \$1,500.00 (One Thousand Five Hundred Dollars Only) from the General Treasury of the Lelu Town Government to finance the Lelu Expo Task Force in its planning meetings.

BE IT ENACTED BY THE 12<sup>TH</sup> LELU TOWN COUNCIL

1 Section 1: Purpose: The purpose and intent of this bill is stated clearly in its title.

2 Section 2: Appropriation: The sum of \$1,500.00 is hereby appropriated from the Lelu Town  
3 General Treasury for the purpose of funding the planning meetings of the Lelu Expo Task  
4 Force.

5 Section 3: Apportionment: The sum appropriated in Section 2 of this Act shall be apportioned  
6 and disbursed as follows:

7 a. Expo Task Force Activity 1,500.00

8 Section 4: Management. The sum appropriated by this Act shall be managed and administered  
9 by the Acting Mayor of the Lelu Town Government and shall be accounted for in accordance  
10 with the Lelu Town Ordinances and applicable rules. The Acting Mayor shall be responsible  
11 for ensuring the sum appropriated is used solely for the purpose for which is apportioned and  
12 that no obligations are incurred in excess of the appropriation.

13 Section 6: Lapse Date: The sum authorized and appropriated by this Act shall be lapsed on  
14 September 30<sup>th</sup>, 2023. Any unobligated amount after the lapse date shall be reverted to the  
15 General Treasury of the Lelu Town Government.


16 Section 7: Effective Date: This Act shall become an ordinance upon the approval by the Acting  
17 Mayor or upon its becoming an ordinance without such signature.


