

1 **WHEREAS**, the Twenty Second Congress of the Federated States of
2 Micronesia appropriated Public Law No. 22-48, Section 3(3)(d) in its
3 Second Regular Session, in the amount of \$50,000.00; and

4 **WHEREAS**, the purpose of the funding is to finance a seawall project
5 from Sroanef to Fwinanpes, Lelu; and

6 **WHEREAS**, Lelu Town Ordinance No. 10-08, as amended, requires that
7 for Foreign, Nation, State and any local donated funds to be valid, it
8 must be approved by 2/3 of the Lelu Town Council by resolution; and

9 **WHEREAS**, the Lelu Town Government wishes to express its
10 appreciation and gratitude to the 22nd Congress of the Federated
11 States of Micronesia and the Kosrae Delegation to the 22nd FSM
12 Congress for grant award; now, therefore,

13 **BE IT RESOLVED** by the 12th Lelu town Council, Third Regular Session,
14 2023, that the 12th LTC hereby approves and accepts the \$50,000.00
15 funding from the FSM Congress, including all the terms and conditions
16 thereof, be approve; and


