A BILL FOR AN ACT

To appropriate the sum of \$600.00 (Six Hundred Dollars only) from the Lelu Town General Treasury to supplement the overtime hours of the chief clerk for fiscal year ending September 2022 and for other purposes.

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose:** The purpose and intent of this bill is
2. stated clearly in its title.
3. **SECTION 2. Appropriation:** The sum of \$600.00 is hereby
4. authorized and appropriated to supplement the Chief Clerk's
5. overtime hours accrued during the 12th Lelu Town Council
6. Regular and Special Sessions.
7. **SECTION 3. Apportionment:** The sum appropriated in Section 2
8. of this Act shall be apportioned and disbursed as follows:
9. a. Chief Clerk Overtime \$600.00
10. **SECTION 4. Management:** The sum appropriated by this Act
11. shall be managed and administered by the Chairman of the
12. Lelu Town Council and shall be accounted for in accordance
13. with the Lelu Town Ordinances and applicable rules. The
14. Chairman shall be responsible for ensuring the sum
15. appropriated is used solely for the purpose for which is
16. apportioned and that no obligations are incurred in excess
17. of the appropriation.

19. by this Act shall be lapsed on September 30th, 2022. Any

24. ordinance upon the approval by the Mayor or upon its
25. becoming an ordinance without such signature.




