A BILL FOR AN ACT


An act to establish a part time deputy clerical position under the Legislative Branch of the Lelu Town Government and to appropriate the sum of \$1,500.00 to fund the deputy clerk and other purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Statement of Indent: The purpose and Indent of this Act is clearly stated
- 2. in its title.
- 3. SECTION 2. Findings. The 11TH LTC encounters difficulties of maintaining timely
- 4. records and journal during sessions or meetings due to shortage of staff. Therefore, the
- 5. 11TH LTC finds it is a necessity to create and establish such position of a part time deputy
- 6. clerk.
- 7. SECTION 3. Position Established. There is hereby created one (1) position of a part time
- 8. deputy clerk for the office of the Lelu Town Council. The deputy clerk shall be a
- 9. contractual position and shall be incorporated under the office of council fiscal year
- 10. operation budget.
- II. SECTION 4. Hiring Authorized. The Chairman is hereby authorized to recruit and hire
- 12. a part time deputy clerk subject to the approval by the Mayor and 2/3 of the Council.
- 13. The hiring shall adhere to the hiring procedure stipulated under section 2.2 and 2.3
- 14. of the LTC Manual of Administration.
- 15. SECTION 5. Contract of Employment. It shall be a duty of the Chairman of Council to
- 16. create the contract of employment and shall be reviewed for consensus by the Mayor
- 17. and 2/3 of the Council.

10.	allowance shall also be prescribed under the contract of employment.		
11.	SECTION 8. Management of Fund. Any funds obligated for the part time deputy		
12.	clerk shall be managed, administered, and accounted for in accordance with		
13.	applicable ordinances.		
14.	SECTION 9. Appropriation. Under this act, the sum of \$1,500.00 is hereby		
15.	appropriated from the Lelu Town Treasury to compensate the duties of the part time		
16.	deputy cler k . The sum shall apportioned as follows:
