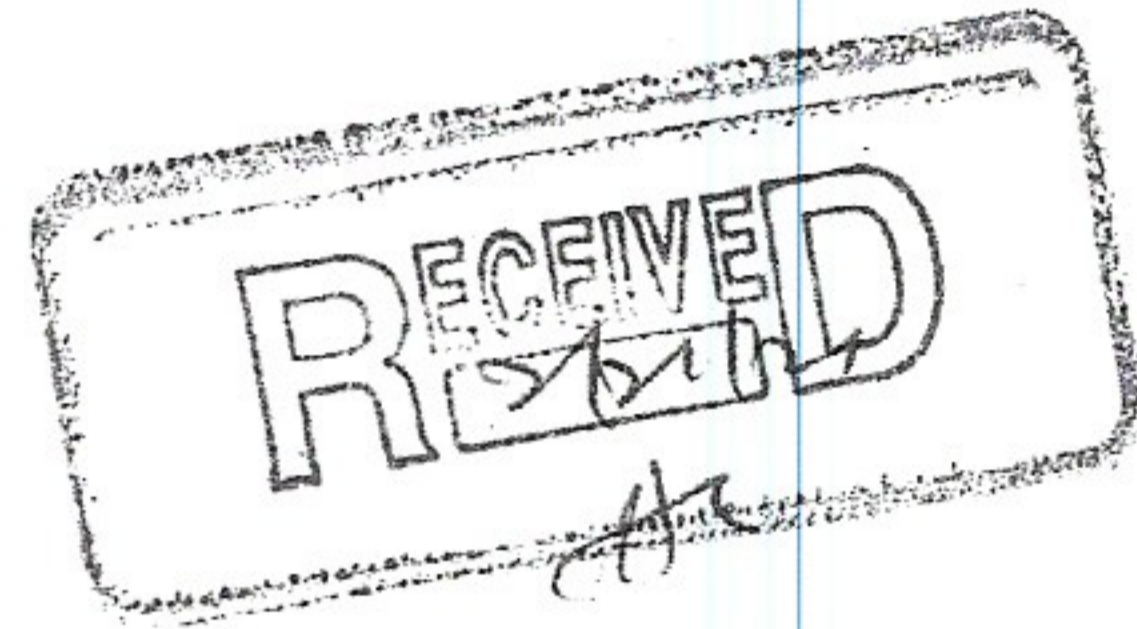



BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:


1. SECTION 1. Section 4, subsection 28 of LTO:10-41 of the Lelu Town


