

BE IT ENACTED BY THE ELEVENTH LELU TOWN COUNCIL:

- 1. **SECTION 1. Purpose and Intent**: The purpose and intent of this Bill is justified clearly

- 3. SECTION 2. Appropriation: The sum of \$500.00 is hereby appropriated from the
- 4. Lelu Town Treasury for the purpose of supporting the dedication Ceremony of the
- 5. building renovated for the Lelu Senior Citizen situated at the Lelu Causeway.
- 6. SECTION 3. Apportionment: The sum appropriated in this Act shall be apportioned as

- 9. SECTION 4. Management: The sum appropriated by this act shall be managed and
- 10. administered by the Mayor and shall be accounted for in accordance with the Lelu Town
- 11. Ordinance and applicable rules. The Mayor shall be responsible for ensuring the sum
- 12. appropriated in this act used solely for the purpose for which is appropriated and that
- 13. no obligations incurred in excess of the appropriation.
