
I am pleased to transmit the following Council Bill, which I have signed into LTO: 11-34: with line item vetoe.





A BILL FOR AN ACT

The authorize and appropriate the sum of eight thousand and four hundred dollars (\$8,400.00) from the Lelu Town Treasury as supplement budget for 11TH Council Cow Session in FY 2020 and for related purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose :** The purpose of this act is clearly stated in its title.
2. **SECTION 2. Appropriation.** The sum of \$8,400.00 is hereby authorized and
3. appropriated for 11TH Cow Sessions in 2020 Fiscal Year.
4. **SECTION 3. Apportionment:** The sum appropriated by this act shall be apportioned as
5. follows:
 6. a) Cow Session \$8,400.00
7. **SECTION 4. Management:** The sum appropriated by this Act shall be managed and
8. administered by the Mayor and shall be accounted for in accordance with the Lelu Town
9. Ordinance and applicable rules. The Mayor shall be responsible for ensuring the sum
10. appropriated is used for the purpose for which is appropriated and that no obligations are
11. incurred in excess of the appropriation.
12. **SECTION 5. Lapse Date:** The sum authorized and appropriated by this Act shall be
13. lapsed on September 30th 2020 and all remaining amount shall be transferred back to the
14. General fund of the Lelu Town Treasury.
15. **SECTION 6. Effective Date:** This Act shall become an ordinance upon approval by the
16. Mayor or upon its becoming an ordinance without such signature.
