A BILL FOR AN ACT

To appropriate the sum of \$2,000.00 from the Lelu Town Treasury for the purpose of funding the operation of the Lelu Election Commission for fiscal year ending September 2023 and for other purposes.

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

- 1. SECTION 1. PURPOSE: The purpose and intent of this
- 2. bill is stated clearly in its title.
- 3. SECTION 2. APPROPRIATION: The sum of \$2,000.00 for
- 4. the operation of the Lelu Election Commission for
- 5. fliscal year ending September 2023.
- 6. SECTION 3. APPORTIONMENT: The sum appropriated by
- 7. this Act shall be apportioned as follows:
- 8. a. LEC \$,2,000.00
- 9. SECTION 4. MANAGEMENT: The sum appropriated by this
- 10. Act shall be managed and administered by the Mayor
- 11. of helu Town Government and shall be accounted for
- 12. in accordance with the Lelu Town Ordinances and
- 13. applicable rules. The Mayor shall be responsible
- 14. for ensuring the sum appropriated is used solely

- 18. SECTION 5. Lapse Date: The sum authorized and

- 22. General Treasury of the Lelu Town Government.
- 23. SECTION 7. EFFECTIVE DATE: This Act shall become
- 24. an ordinance upon the approval by the Mayor or upon
- 25. its becoming an ordinance without such signature.
