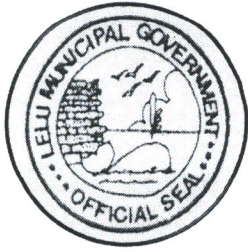

A RESOLUTION

Approving and accepting a Congressional assistant fund in the amount of \$100,000.00 from the General Fund of the Federated States of Micronesia for fiscal year 2023 under Public Law 22-180, to supplement funding for the Sroanef to Pukusruk seawall project.

- 1 **WHEREAS**, the Congress of the Federated States of Micronesia issued Public
2 Law No. 22-180 dated January 4th, 2023, for fiscal year ending September
3 30th, 2023 in the amount of \$100,000.00; and
4 **WHEREAS**, the purpose of the funding is to supplement funding for the
5 Sroanef to Pukusruk seawall project; and
6 **WHEREAS**, Lelu Town Ordinance No.10-08, as amended, requires that for
7 Foreign, National, State and any local donated funds to be valid, it must be
8 approved by 2/3 of the Lelu Town Council by resolution; and
9 **WHEREAS**, the Lelu Town Government wishes to express its appreciation to
10 the Congress of the Federated States of Micronesia, most especially the
11 Kosrae Delegation for the grant award; now, therefore,

12 **BE IT RESOLVED** by the 12th Lelu Town Council, Fourth Special Session,
13 2023, that the 12th LTC hereby approves and accepts the \$100,000.00
14 funding from the FSM Congress, including all the terms and conditions
15 thereof, be approved; and

16 **BE IT FURTHER RESOLVED**, that certified copies of this Resolution be
17 transmitted to the Speaker of the FSM Congress, the Chairman of the Kosrae
18 Delegation-FSM Congress, the Mayor of the Lelu Town Government, and the
19 Chairman of the Lelu Town Council.
