A BILL FOR AN ACT

To adopt into ordinance a chief mechanic position under the Executive Branch of the Lelu Town Government and for other purposes.

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

1. **SECTION 1. Findings and Intent:** It is the finding of the
2. 12th LTC that some of the equipment owned by the Lelu Town
3. Government are currently not in service due to
4. unavailability of parts and limited mechanical skills of
5. staff. This is evident of the number of heavy equipment
6. being placed and parked around the LTG vicinity. Therefore,
7. the 12th LTC finds it necessity to create and establish the
8. chief mechanic position to oversee and manage the
9. mechanical operation.
10. **SECTION 2. Position Established:** There is hereby created
11. one (1) position of a chief mechanic for the office of the
12. Lelu Town Government. The chief mechanic shall be a
13. permanent position and shall be incorporated under the
14. office of the Mayor fiscal year operational budget.
15. **SECTION 3. Hiring Authorized.** The Mayor is hereby
16. authorized to recruit and hire the chief mechanic subject
17. to the approval by 2/3 of the Council. The hiring shall

18. adhere to the hiring procedure stipulated under section

19. 2.2 and 2.3 of the LTG Manual of Administration.

20. **SECTION 4. Salary:** The salary of the chief mechanic shall

21. be equivalent to six thousand nine hundred fifty three

22. and eighty six cents (\$6,953.86) per annum.

23. **SECTION 5. Effective Date:** This act shall become effective

24. upon approval by the Mayor or upon its becoming an

25. ordinance without such signature.


