
A BIL FOR AN ACT

To appropriate the sum of Five Hundred Dollars (\$500.00) from the Lelu Town Treasury to supplement the operational cost of the Lelu Town Government for period ending September 30,2020, and for other purposes.

BE IT ENACTED BY THE ELEVENTH LELU TOWN COUNCIL:

- 1. **SECTION 1. Purpose**: The purpose and intent of this act is stated clearly in its title.
- 2. SECTION 2. Appropriation: The sum of five hundred dollars (\$500.00) is hereby
- 3. authorized and appropriated for the procurement of an outrigger canoe sold to Lelu
- 4. Town Government by Utwe Gateway Group.
- 5. SECTION 3. Apportionment: The sum appropriated by this act shall be apportioned
- 6. as follows:
- 7. a) Miscellaneous Expense \$500.00
- 8. SECTION 4. Management: The sum appropriated by this Act shall be managed and
- 9. administered by the Mayor and shall be accounted for in accordance with the
- 10. Lelu Town Ordinance and applicable rules. The Mayor shall be responsible for ensuring
- 11. the sum appropriated is used for the purpose for which appropriated and that no
- 12. obligations are incurred in excess of the appropriation.
- 13. SECTION 5. Lapse Date: The sum appropriated by this act shall be lapsed on
- 14. September 30,2020 and all remaining amount shall be transferred back to the General
- 15. Fund of the Lelu Town Treasury.
- 16. SECTION 6. Effective Date: This act shall become effective upon the signature of the
- 17. Mayor or upon its approval without such signature.
