#### A BILL FOR AN ACT


Relating to creation and establishment of Ranger positions under the Executive Branch of the Lelu Town Government.

### BE IT ENACTED BY THE ELEVENTH LELU TOWN COUNCIL:

- 1. SECTION I. Statement of Indent. The purpose of this act is clearly stated in its
- 2. title.
- 3. SECTION 2. Findings. The 11<sup>TH</sup> LTC and the Executive branch encountered the
- 4. difficulties to maintain the full operation of Awane Marine Park due to absence
- 5. and unavailability of rangers.
- 6. SECTION 3. Position Established. There is hereby created two (2) positions of
- 7. Rangers as may from time to time be hired by the Mayor. The Rangers shall be
- 8. entitled for training in order to acquire required certification from the state
- 9. police standards.
- 10. **SECTION 4.** Hiring Authorized. The Mayor is hereby authorized to recruit
- 11. and hire Rangers subject to the advise and consent of the Lelu Town Council.
- 12. SECTION 5. Duties of Rangers. The responsibilities of the Rangers are protecting
- 13. and supervising the designated Awane Marine Park areas, ensuring the visitors
- 14. are following the rules and regulation set-forth for the Awane Marine Park and
- 15. enforcing the state environment laws and regulations, maintain the cleanliness

1.	of the Awane Marine Park for the good of the public, maintain the infrastructures		
2.	within the Awane Marine Park, collect usage fees, prepare and submit monthly		
3.	report, quarterly report, annual report and perform other duties as may be assigned

5.	SECTION 6. Salary. The salary of each position shall be ranged from \$3,000.00 -		
6.	\$4,000.00 per annum or depending upon qualification. Mayor shall be responsible		
7.	to make necessary adjustment with the consent of two-third (2/3) of the Council.		
8.	SECTION 7. Effective Date. This act shall become effective upon approval by the		
9.	Mayor or upon its becoming an ordinance without such signature.
