
Dear Honorable Chairman Nedlic:

**A BILL FOR AN ACT**

To appropriate the sum of \$1,280.20 from the Lelu Town Treasury to offset an outstanding debt with the FSM Kosrae and for related purposes.

**BE IT ENACTED BY THE 11<sup>TH</sup> LELU TOWN COUNCIL:**

1. **SECTION 1. Appropriation.** The sum of \$1,280.20 is hereby appropriated from the
2. Lelu Town Treasury to offset an outstanding debt with the FSMTC Kosrae.
3. **SECTION 2. Management.** The sum appropriated by this Act shall be managed and
4. administered by the Mayor and shall be accounted for in accordance with the Lelu Town
5. Ordinances and applicable rules. The Mayor shall be responsible for ensuring the amount
6. appropriated is used for the purpose for which is appropriated and that no obligations are
7. incurred in excess of the appropriation.
8. **SECTION 3. Lapse Date.** The amount appropriated by this Act shall be lapsed on
9. September 30<sup>th</sup> 2020 and all remaining amount shall be transferred back to the General
10. fund of the Lelu Town Treasury.
11. **SECTION 4. Effective Date.** This Act shall become effective upon approval by the
12. Mayor or upon its becoming an ordinance without such signature.


