A BILL FOR AN ACT

To appropriate the sum of \$1,280.20 from the Lelu Town Treasury to offset an outstanding debt with the FSM Kosrae and for related purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. **SECTION 1. Appropriation.** The sum of \$1,280.20 is hereby appropriated from the
- 2. Lelu Town Treasury to offset an outstanding debt with the FSMTC Kosrae.
- 3. SECTION 2. Management. The sum appropriated by this Act shall be managed and
- 4. administered by the Mayor and shall be accounted for in accordance with the Lelu Town
- 5. Ordinances and applicable rules. The Mayor shall be responsible for ensuring the amount
- 6. appropriated is used for the purpose for which is appropriated and that no obligations are
- 7. incurred in excess of the appropriation.
- 8. SECTION 3. Lapse Date. The amount appropriated by this Act shall be lapsed on
- 9. September 30th 2020 and all remaining amount shall be transferred back to the General
- 10. fund of the Lelu Town Treasury.
- 11. SECTION 4. Effective Date. This Act shall become effective upon approval by the
- 12. Mayor or upon its becoming an ordinance without such signature.
