

#### A BILL FOR AN ACT

To amend Section 3 of the Lelu Town Ordinance No. 11-37 for the purpose of extending the lapse date of LTO.11-37 from September 30, 2020 to September 30, 2021 and for other purposes.

#### BE IT ENACTED BY THE 11<sup>TH</sup> LELU TOWN COUNCIL:

- 1. **SECTION 1. Appropriation**. The sum of \$1,280.20 is hereby appropriated from the
- 2. Lelu Town Treasury to offset an outstanding debt with the FSMTC Kosrae.
- 3. SECTION 2. Management. The sum appropriated by this Act shall be managed and
- 4. administered by the Mayor and shall be accounted for in accordance with the Lelu
- 5. Town Ordinances and applicable rules. The Mayor shall be responsible for ensuring the
- 6. amount appropriated is used for the purpose for which is appropriated and that no
- 7. obligations are incurred in excess of the appropriation.
- 8. SECTION 3. Lapse Date. The amount appropriated by this Act shall be lapsed on
- 9. September 30, 2021 and all remaining amount shall be transferred back to the General
- 10. Fund of the Lelu Town Treasury.
- 11. **SECTION 4. Effective Date**. This Act shall become effective upon approval by the
- 12. Mayor or upon it's becoming an ordinance without such signature.
