BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL.

- l. Section 1: Purpose: The purpose and intent of this bill is stated clearly in its title.
- 2. Section 2: Appropriation: The sum of \$1,100.00 is hereby appropriated from the Lelu
- 3. Town General Treasury for the purpose of funding the installation of a website for LTG.
- 4. Section 3: Apportionment: The sum appropriated in Section 2 of this Act shall be apportioned
- 5. and disbursed as follows

6.	A. Lelu Town Government Webs	1,100.00	
7.	a. Administrator	500.00	
8.	b. Hosting	75.00	
9.	c. Calendar	25.00	
10.	d. Assistant Trainer	500.00	

- II. Section 4: Management: The sum appropriated by this Act shall be managed and administered by
- 12. the Chairman of the Lelu Town Council and shall be accounted for in accordance with the Lelu
- 13. Town Ordinances and applicable rules. The Chairman shall responsible for ensuring the sum
- 14. Appropriated is used solely for the purpose for which is apportioned and that no obligations are
- 15. incurred in excess of the appropriation.
- 16. Section 6: Lapse Date: The sum authorized and appropriated by this act shall be lapsed on
- 17. September 30th, 2023. Any unobligated amount after the lapse dare shall be transferred back
- 18. to General Treasury of the Lelu Town Government.
- 19. Section 7: Effective Date: This Act shall become an ordinance upon the approval by the Mayor
- 20. Or upon its becoming an ordinance without such signature.
