A BILL FOR AN ACT

To appropriate the sum of \$4,350.00 (Four Thousand Three Hundred Fifty Dollars Only) from the General Treasury of the Lelu Town Government for the purpose of supplementing the COW meeting of the 12<sup>th</sup> Lelu Town Council and for other purposes.

BE IT ENACTED BY THE 12<sup>TH</sup> LELU TOWN COUNCIL

1 Section 1: Purpose: The purpose and intent of this bill is stated clearly in its title.

2 Section 2: Appropriation: The sum of \$4,350.00 is hereby appropriated from the Lelu Town  
3 General Treasury to supplement the COW Meetings of the Lelu Town Council.

4 Section 3: Apportionment: The sum appropriated in Section 2 of this Act shall be apportioned  
5 and disbursed as follows:

6 a. COW Meeting 4,350.00

7 Section 4: Management. The sum appropriated by this Act shall be managed and administered  
8 by the Chairman of the Lelu Town Council and shall be accounted for in accordance with the  
9 Lelu Town Ordinances and applicable rules. The Chairman shall be responsible for ensuring  
10 the sum appropriated is used solely for the purpose for which is apportioned and that no  
11 obligations are incurred in excess of the appropriation.

12 Section 6: Lapse Date: The sum authorized and appropriated by this Act shall be lapsed on  
13 September 30<sup>th</sup>, 2023. Any unobligated amount after the lapse date shall be transferred back to  
14 the General Treasury of the Lelu Town Government.

15 Section 7: Effective Date: This Act shall become an ordinance upon the approval by the Mayor  
16 or upon its becoming an ordinance without such signature.


