

A BILL FOR AN ACT

To appropriate the sum of \$2,400.00 (Two Thousand Four Hundred Dollars only) from the Lelu Town Government General Treasury to supplement the operation of the Legislative Branch for Fiscal Year 2023 and for other purposes.

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

- 1. SECTION 1. PURPOSE: The purpose and intent of this bill is
- 2. stated clearly in its title.
- 3. **SECTION 2. APPROPRIATION:** The sum of \$2,400 is hereby
- 4. authorized and appropriated to supplement the operation of
- 5. the Legislative Branch of the Lelu Town Government for
- 6. FY2023.
- 7. **SECTION 3. APPORTIONMENT:** The sum appropriated in Section 2
- 8. of this Act shall be apportioned and disbursed as follows:
- 9. a. Special Session \$2,400.00
- 10. i. 7 members x 4 meetings \$2,100.00
- 11. ii. 1 Deputy Clerk x 4 meetings \$ 300.00
- 12. **SECTION 4. MANAGEMENT:** The sum appropriated by this Act
- 13. shall be managed and administered by the Chairman of the
- 14. Lelu Town Council and shall be accounted for in accordance
- 15. with the Lelu Town Ordinances and applicable rules. The
