A BILL FOR AN ACT

To appropriate the sum of \$223.20 from the Lelu Town Government Treasury for the fiscal year ending September 30, 2019 for the purpose of compensating the cost of overtime for the chief clerk of the Lelu Town Council for performing work outside of normal working hours during regular and special sessions of the Lelu Town Council and for other purposes.

BE IT ENACTED BY THE ELEVENTH LELU TOWN COUNCIL:

1. SECTION 1. Purpose and Intent: The purpose of this Act is to
2. appropriate the sum of \$223.20 from the Lelu Town Treasury for the
3. fiscal year ending September 30, 2019 for the purpose of funding overtime
4. cost for the chief clerk of the Lelu Town Council for the work perform
5. outside Government normal working hours.
6. SECTION 2. Verification of hourly rate and overtime hourly rate: following
7. are the regular hourly rate and the overtime hourly rate for the chief clerk of
8. the Lelu Town Council.
9.           a) Regular Hourly Rate - \$3.72
10.           b) Over Time Hourly Rate - \$5.58
11. SECTION 3. Eligibility: In order to be eligible for overtime, the employee
12. shall work and compete thirty two (32) hours a week. Any hours worked
13. excess of thirty two (32) government regular working hours shall be treated
14. and compensated as overtime at the rate of  $\$3.72 \times 1.5 = 5.58$ .

1. SECTION 4. Apportionment: All funds appropriated in the amount of
  2. \$223.20 shall be apportioned as follow using the minimum rate of (2)
  3. hours for each meeting if the length of the meeting exists (2) hours.
  4.       a) First Regular Session- (10 Session days\*2 hours minimum each
  5.       day at the cost of 11.16 per meeting=\$116.60)
  6.       b) Second Regular Session-(10 Session days\*2 hours minimum each
  7.       day at the cost of 11.16 per meeting=116.60)
  8. SECTION 5. Management of Fund: All fund appropriated in this act shall
  9. be managed, controlled administered and accounted for in accordance with
  10. applicable laws , included, but not limited to, the Financial Act 2007. The
  11. Mayor shall be responsible for ensuring that this fund, and so much thereof
  12. as may be necessary, are use solely for the purpose specified in this act, and
  13. that no obligation is incurred in excess of the sum appropriated. The sum
  14. appropriated by this act shall lapsed on September 30, 2019. Any amount
  15. not obligated at the end of the lapsed date shall be referred back to the
  16. Lelu Town Treasury.
