**A BILL FOR AN ACT**

To establish a curfew ordinance for the Municipality of Lelu and for other purposes.

**BE IT ENACTED BY THE ELEVENTH LELU TOWN COUNCIL:**

1. **SECTION 1. Purpose:** The purpose of this act is to ordain an  
2. ordinance establishing curfew hours, to strengthen minor's  
3. health, to motivate minor's appearance in school, to avert  
4. minor from ~~violate~~ <sup>violate</sup> any municipal ordinances or state law,  
5. and further establish the responsibilities and liabilities  
6. of Parents and guardian involving this act.

7. **SECTION 2. Definition:** For the purpose of this act, the  
8. following terms shall have the following meaning.

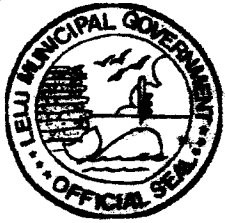
9. (1) Minor- A person under the age of eighteen

10. (2) Parent- A father or a Mother of a minor  
11. person.

12. (3) Guardian- A person having the lawful care and  
13. custody over a minor person.

14. **SECTION 3. Enactment:** An ordinance hereby enacted to

16. (A) No minor under the age of eighteen shall



18.       3. **Third Offense** and beyond - Fine (\$20.00)

19. **SECTION 6. Fines:** Any money collected on fines and  
20. penalties by Treasurer will be deposited and recorded to  
21. the Lelu Town Government Treasury.
