A BILL FOR AN ACT

To amend LTO 11-24 by amending sections 1 and 4 thereof, to change the section heading and the lapse date and for other purposes.

BE IT ENACTED BY THE 11<sup>TH</sup> LELU TOWN COUNCIL:

1. SECTION 1. APPROPRIATION. The sum of \$10,000.00 is hereby  
2. appropriated from the Lelu Town Treasury to cover all costs related  
3. to the establishment of a local trading center for the people of Lelu  
4. for the fiscal Year Ending September 2021.

5. SECTION 2. APPORTIONMENT. The sum appropriated by this Act  
6. shall be apportioned as follows:

7.	a) Contractual Services	\$3,500.00
8.	b) Contingencies	\$3,500.00
9.	c) All others	\$3,000.00

10. SECTION 3. MANAGEMENT. The sum appropriated by this Act shall  
11. be managed and administered by the Mayor of Lelu and shall be  
12. accounted for in accordance with the Lelu Town Ordinance and  
13. applicable laws. The Mayor shall be responsible for ensuring the  
14. amount appropriated is used for the purpose for which appropriated  
15. and that no obligations are incurred in excess for the appropriation.

16. SECTION 4. Lapse Date. The sum appropriated by this act shall be  
17. lapse on September 30, 2021 and all remaining amount shall be
