BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose and Intent: To amend Section 7.3 of the
- 2. Lelu Town Government Manual of Administration be changed
- 3. to read as follows:
- 4. "Section 7.3 Annual Vacation
- 5. For each fiscal year, each staff member who is holding
- 6. permanent employment (Treasurer & Police Officer) with
- 7. LTG is entitled for paid vacation for not more than 23
- 8. working days, equates to 150 hours irrespective of number
- 9. of years in service. In case of emergencies the Mayor or
- 10. the Chairman of the Council may re-call appropriate staffs
- 11. to perform their duties."
- 12. SECTION 2. Effective Date: This Act shall become effective
- 13. upon signature of the Mayor or upon its approval without
- 14. such signature.
