



A BILL FOR AN ACT

To appropriate the sum of \$18,000.00 from the CFMSM Fund for the purpose of renovating Lelu Basketball court and for other purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose and Intend:** The purpose and intend of this act
2. is clearly stated in its title.

3. **SECTION 2. Appropriation:** The sum of \$18,000.00 is hereby
4. authorized and appropriated from the CFMSM Fund to provide
5. funding for the Renovating of Lelu Basketball court for Fiscal year
6. ending year September 2022.

7. **SECTION 3. Apportionment:** The sum appropriated by this Act shall
8. be apportioned as follows:

9. (A) Contractual \$ 18,000.00

10. **SECTION 4. Management:** The sum appropriated by this Act shall be
11. managed and administered by the Mayor and shall be accounted for
12. in accordance with the Lelu Town Ordinances and applicable rules.

13. The Mayor shall be responsible for ensuring the sum appropriated is
14. used solely for the purpose for which is appropriated and that no
15. obligations are incurred in excess of this appropriation.

16. **SECTION 5. Lapse Date.** The sum authorized and appropriated by
17. this Act shall be lapsed on September 30th 2022.
