

### A BILL FOR AN ACT

To appropriate the sum of Two Thousand Eight Hundred Dollars (\$2,800.00) from the Lelu Town Treasury to supplement the Operation of the Executive Branch of the Lelu Town Government for period ending September 30, 2020 and for other purposes.

# BE IT ENACTED BY THE 11<sup>TH</sup> LELU TOWN COUNCIL:

- SECTION 1. Purpose: The purpose and intent of this act is stated clearly in its title.
   SECTION 2. Appropriation: The sum of two thousand eight hundred dollars
   (\$2,800.00) is hereby authorized and appropriated to supplement the Operation of the
   Executive Branch of the Lelu Town Government.
   SECTION 3. Apportionment: The sum appropriated by this act shall be apportioned as
   follows:
- 7. a) Supplies Expenditures \$ 2,000.00
- 8. b) Equipment Parts \$ 800.00
- 9. **SECTION 4. Management**. The sum appropriated by this Act shall be managed and
- administered by the Mayor and shall be accounted for in accordance with the Lelu TownOrdinance and applicable rules. The Mayor shall be responsible for ensuring the sum
- 12. appropriated is used for the purpose for which is appropriated and that no obligations are
- 13. incurred in excess of the appropriation.
- 14. **SECTION 5. Lapse Date**: The sum appropriated by this act shall be lapsed on
- 15. September 30,2020 and all remaining amount shall be transferred back to the
- 16. General Fund of the Lelu Town Treasury.
- 17. **SECTION 6. Effective Date**: This Act shall become effective upon the signature of the
