BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose and Intent: To amend Sub-section 11.2 of
- 2. Section 11 of the LTG Manual of Administration.
- 3. SECTION 2. Findings: With the importance of time, numbers
- 4. and other purposes, the 11^{TH} Town Council of the Lelu Town
- 5. Council agreed to add-on a specific number to accommodate
- 6. the exact number of months and employee can still be
- 7. considered absent from work before being terminated and
- 8. shall be read as follows:
- 9. Section 11: Separation
- 10. Sub-section 11.2: Termination
- 11. " A staff member can be terminated for the following
- 12. reasons:
- 13. Absence from duty for 6 months because of medical
- 14. problems. An examination report from a certified physician
- 15. to affect the termination must be in place prior to
- 16. displacement. Unsatisfactory work performance is another
- 17. ground for removal of staff member. Dishonesty and being

18.	convicted of a crime will also be used or remove a staff
19.	from employment with LTG.
20.	Reduction in Force may come at circumstances where LTG
21.	should abolish position to level off with its fiscal
22.	condition.
23.	SECTION 3. Effective Date: This Act shall become effective
24.	upon signature of the Mayor or upon its approval without
25.	such signature.
