





To amend Sub-section 11.2 of Section 11 of the Lelu Town Government's Manual of Administration by inserting the number of absence before being terminated.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose and Intent:** To amend Sub-section 11.2 of
2. Section 11 of the LTG Manual of Administration.
3. **SECTION 2. Findings:** With the importance of time, numbers
4. and other purposes, the 11TH Town Council of the Lelu Town
5. Council agreed to add-on a specific number to accommodate
6. the exact number of months and employee can still be
7. considered absent from work before being terminated and
8. shall be read as follows:
9. Section 11: Separation
10. Sub-section 11.2: Termination
11. " A staff member can be terminated for the following
12. reasons:
13. Absence from duty for 6 months because of medical
14. problems. An examination report from a certified physician
15. to affect the termination must be in place prior to
16. displacement. Unsatisfactory work performance is another
17. ground for removal of staff member. Dishonesty and being






