A BILL FOR AN ACT

To appropriate the sum of \$ 10,000.00 from the General Fund /CFSM Fund for the purpose of purchasing two unit vehicle for the office of the Council and Executive office and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE LELU TOWN GOVERNMENT

- SECTION 1. The sum of \$ 10,000.00, or so much thereof as may be necessary 1. 2. is hereby appropriated from the General Fund of the Lelu Town Treasury / CFSM Fund for 3. the fiscal year ending September 30, 2016, for the purpose of funding two unit vehicle for 4. the office of the Lelu Town Council and Executive Office. The funds appropriated under this 5. section shall be apportioned as follows: 1. Two Unit Vehicle......\$ 10,000.00 6. SECTION 2. Allotment and Management of Funds. All funds appropriated by act 7.
- 8. shall be allotted, manage, administered and accounted for in accordance with applicable 9. laws, including, but not limited to the Financial Management Act of 2007. The allottee shall 10. be responsible in ensuring that these funds, or so much thereof as may be necessary, are 11. use solely for the purpose specified in this act, and that no obligations are incurred in 12. excess of the sum appropriated. The allottee of the fund appropriated under section 1 of 13. this act shall be the Mayor of Lelu Town Government or his designee. The authority of the 14. allottee to obligate such funds shall lapse on September 30, 2016 and any unallotted funds 15. will be revered back to the General Fund of the Lelu Town Government.
- SECTION 3. This act shall become law upon the approval of the Mayor of Lelu 16. 17. Town Government or upon its becoming law without such signature.
