To amend Sub-section 11.3 of Section 11 of the Lelu Town Government Manual of Administration by replacing the word "no" With "5 days".

# BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose and Intent: That sub-section 11.3 of
- 2. Section 11 of the LTG MOA be amended and read as follows:
- 3. Section 11: Separation
- 4. Sub-section 11.3. Notice
- 5. In case of medical and unsatisfactory performance, LTG
- 6. shall service Notice of its proposed termination action
- 7. no less than 30 days in advance.
- 8. For reduction in force, notice shall be made no less than
- 9. 60 days. Removal because of dishonesty and being convicted
- 10. of a felony, "5 days" notice is required.
- 11. SECTION 2. Amendments, To replace the word "no" with "5
- 12. days" under Sub-section 11.3 Notice of the LTG MOA.
- 13. SECTION 3. Effective Date: This Act shall become effective
