

A BILL FOR AN ACT

To appropriate the sum of \$3,000.00 (Three Thousand Dollars only) for the purpose of supplementing the operation of the Lelu Town Government for fiscal year ending September 2022 and for other purposes.

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose: The purpose and intent of this bill
- 2. is stated clearly in its title.
- 3. SECTION 2. Appropriation: The sum of \$3,000.00 is hereby
- 4. appropriated from the Lelu Town General Treasury to
- 5. supplement the operation of the Lelu Town Government as
- 6. stated in its title.
- 7. SECTION 3. Apportionment: The sum appropriated in Section
- 8. 2 of this Act shall be apportioned and disbursed as
- 9. follows:
- 10. a. Consumable 3,000.00
- 11. (1) Oxygen/Acetylene
- 12. w/shipping & handling charges
- 13. SECTION 4. Management : The sum appropriated by this Act
- 14. shall be managed and administered by the Mayor of Lelu Town
- 15. Government and shall be accounted for in accordance with
- 16. the Lelu Town Ordinances and applicable rules. The Mayor
- 17. shall be responsible for ensuring the sum appropriated is

19.	that no obligation are incurred in excess of the
20.	appropriation.
21.	SECTION 5. Lapse Date: The sum authorized and appropriated
22.	by this Act shall be lapsed on September 30th, 2022. Any
23.	unobligated amount after the lapse date shall be
24.	transferred back to the General Treasury of the Lelu
25.	Town Government.
26.	SECTION 6. Effective Date: This Act shall become an
27.	ordinance upon the approval by the Mayor or upon its
28.	becoming an ordinance without such signature.
