





BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose and Intent:** The purpose and intent of
2. this Act is to authorize overtime compensation to all
3. employees.
4. **SECTION 2. Amendment:**
5. 8.4. Overtime
6. "Any staff member who is directed to work more
7. than 32 hours each week shall be paid overtime
8. at the rate of one half times his or her basic
9. pay rate. Work on legal holidays shall be paid
10. twice the basic pay rate.
11. **SECTION 3. Effective Date:** This Act shall become law upon
12. its approval by the Mayor or upon its becoming law without


