
Dear Honorable Chairman Nedlic,







**BE IT ENACTED BY THE 11<sup>TH</sup> LELU TOWN COUNCIL:**

1.       **SECTION 1. Purpose:** The purpose and intend of this bill
2.       is stated clearly in its title.
3.       **SECTION 2. Appropriation:** The sum of \$600.00 is hereby
4.       authorized and appropriated to fund the officials of a
5.       Fast- Pitch Tournament implemented by the Park and

7.       **SECTION 3. Apportionment:** The sum appropriated in
8.       section 2 of this Act shall be apportioned and
9.       disbursed as follows:
10.       a) Tournament Officials                                       \$600.00
11.       **SECTION 4. Management:** The sum appropriated by this
12.       Act shall be managed and administered by the Mayor and
13.       shall be accounted for in accordance with the Lelu
14.       Town Ordinances and applicable rules. The Mayor shall
15.       be responsible for ensuring the sum appropriated is

21. 30<sup>th</sup>, 2021.






