





A BILL FOR AN ACT

To amend Section 3 and Section 7 of the Lelu Town Ordinance No. 07-06 and for other purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1.** Amendment: Section 3 of the Lelu Town Ordinance No.7-06 to be
2. amended to read as follows:
3. **“SECTION 3. Authority to Stop Payment:** The Lelu Town Council by the authority
4. vested in it by Article VI, Section 6, of the Lelu Town Charter shall direct the Town
5. Treasurer to stop payment on any obligations not authorized by the Lelu Town budget
6. or the Town Council by ordinance.”
7. **“SECTION 7. Penalty:** Violation of this law by any employees of the Lelu Town
8. Government may lead to an investigation to be conducted by designees from opposite
9. branches of the Government, and if there is ground of violation, violators shall be
10. receiving disciplinary actions that may lead to suspension, demotion from current
11. positions, salary reduction and may also be prosecuted under any applicable statutes, and
12. termination and/or removal if warranted.
13. **SECTION 8. Effective Date:** This Act shall become law upon its approval by the Mayor
14. or upon its becoming law without such approval.
