

A BILL FOR AN ACT

To amend Section 3 and Section 7 of the Lelu Town Ordinance No. 07-06 and for other purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. **SECTION 1**. Amendment: Section 3 of the Lelu Town Ordinance No.7-06 to be
- 2. amended to read as follows:
- 3. "SECTION 3. Authority to Stop Payment: The Lelu Town Council by the authority
- 4. vested in it by Article VI, Section 6, of the Lelu Town Charter shall direct the Town
- 5. Treasurer to stop payment on any obligations not authorized by the Lelu Town budget
- 6. or the Town Council by ordinance."
- 7. "SECTION 7. Penalty: Violation of this law by any employees of the Lelu Town
- 8. Government may lead to an investigation to be conducted by designees from opposite
- 9. branches of the Government, and if there is ground of violation, violators shall be
- 10. receiving disciplinary actions that may lead to suspension, demotion from current
- 11. positions, salary reduction and may also be prosecuted under any applicable statutes, and
- 12. termination and/or removal if warranted.
- 13. **SECTION 8. Effective Date:** This Act shall become law upon its approval by the Mayor
- 14. or upon its becoming law without such approval.
