A BILL FOR AN ACT

To authorize and appropriate the sum of Thirty Thousand Dollars (\$30,000.00) from the FSM National Treasury to supplement the Lelu Town Government Operations for fiscal year ending September 2021 and for other purposes.

**BE IT ENACTED BY THE 11<sup>TH</sup> LELU TOWN COUNCIL:**

1.           **SECTION 1. Purpose.** The purpose and intent of this act is stated  
2.           clearly in its title.

3.           **SECTION 2. Appropriation.** The sum of \$30,000.00, as a subsidy  
4.           from the FSM Congress to the Lelu Town Government, is hereby  
5.           authorized and appropriated to supplement the operation costs of  
6.           the Lelu Town Government.

7.           **SECTION 3. Apportionment.** The sum appropriated in Section 2 of  
8.           this Act shall be apportioned and disbursed as follows:

9.	a. Personnel	\$21, 228.00
10.	b. Consumables	\$ 2,772.00
11.	c. Fixed Assets	\$ 6,000.00

12.           **SECTION 4. Management.** The sum appropriated by this Act shall be  
13.           managed and administered by the Mayor and shall be accounted for  
14.           in accordance with the Lelu Town Ordinance and applicable rules.

15.           The Mayor shall be responsible for ensuring the sum appropriated  
16.           is used solely for the purposed for which is apportioned and that no

17. obligations are incurred in excess of the appropriation.

18. **SECTION 5. Lapse Date.** The sum authorized and appropriated by  
19. this act shall be lapsed on September 30<sup>th</sup>, 2021 and all remaining  
20. amount shall be transferred back to the General Fund of the Lelu  
21. Town Treasury.

22. **SECTION 6. Effective Date.** This act shall become an ordinance upon  
23. the approval by the Mayor or upon its becoming an ordinance  
24. without such signature.
