BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose and Intent: To amend Sub-section 10.2 of
- 2. section 10 of the LTG Manual of Administration.
- 3. SECTION 2. Findings. The 11^{TB} Town Council of the Lelu Town
- 4. Government agreed to insert a new line to address more on
- 5. authorized travel expenses and shall be amended to be read
- 6. as follows:
- 7. Section 10: Travel
- 8. Sub-Section 10.2 : Travel Authorization
- 9. " A travel Authorization Form shall be established to
- 10. record all travel requests. The approval authority for
- 11. all travel is the Council. The Council shall jointly
- 12. make a decision toward all travel. Travel at government
- 13. expenses is authorized only to conduct official
- 14. government business".
- 15. SECTION 3. Effective Date: This Act shall become effective
- 16. upon signature of the Mayor or upon its approval without
- 17. such signature.
