

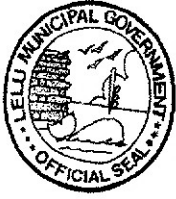

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose and Intent:** To amend Sub-section 10.2 of
2. section 10 of the LTG Manual of Administration.
3. **SECTION 2. Findings.** The 11TH Town Council of the Lelu Town
4. Government agreed to insert a new line to address more on
5. authorized travel expenses and shall be amended to be read
6. as follows:
7. Section 10: Travel
8. Sub-Section 10.2 : Travel Authorization
9. " A travel Authorization Form shall be established to
10. record all travel requests. The approval authority for
11. all travel is the Council. The Council shall jointly
12. make a decision toward all travel. Travel at government
13. expenses is authorized only to conduct official
14. government business".
15. **SECTION 3. Effective Date:** This Act shall become effective
16. upon signature of the Mayor or upon its approval without
17. such signature.
