



1. **SECTION 1. Purpose and Intent:** To insert a new sub-section
2. 10.2 of Section 10 of the LTG MOA be amended to read as

4. Section 10: Travel
5. Sub-Section 10.2:Travel Authorization
6. " A travel Authorization Form shall be established to
7. record all travel requests. The approval authority for all
8. travel is the Council. The Council shall jointly make a
9. decision toward all travel. Travel at government expense
10. is authorized only to conduct official government
11. business".
