To amend Sub-section 11 2 of Section 11 of the Lelu Town Government Manual of Administration by replacing the word "crime" with "felony".

## BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose and Intent: That sub-section 11.2 of
- 2. Section 11 of the LTG MOA be amended to replace "crime"
- 3. in line item 10 with "felony" to read as follows:
- 4. Section 11: Separation
- 5. Sub-section 11.2 Termination
- 6. " A staff member can be terminated for the following
- 7. reasons:
- 8. Absence from duty within a consideration period of time
- 9. because of medical problems.
- 10. An examination report from a certified physician to affect
- 11. the termination must be in place prior to displacement.
- 12. Unsatisfactory work performance is another ground for
- 13. removal of staff member. Dishonesty and being convicted of
- 14. a felony will also be used or remove a staff from
- 15. employment with LTG. Reduction in Force may come at
- 16. circumstances where LTG should abolish position to level
- 17. off with its fiscal condition.

20.	SECTION 3. Effective Date: This Act shall become effective
21.	upon signature of the Mayor or upon its approval without
