



**A BILL FOR AN ACT**

To amend Section 7.3 of the Lelu Town Manual of Administration by inserting two new sub-section for newly appointed employees and approval of leave request and for other purposes.

**BE IT ENACTED BY THE 11<sup>TH</sup> LELU TOWN COUNCIL:**

1. **SECTION 1. Purpose:** The purpose of this Act is to
2. amend the Lelu Town Manual of Administration, section
3. 7.3 by inserting two new sub-sections for newly
4. appointed LTG employees and approval of leave request
5. by the Mayor or the Chairman of the Council.
6. **SECTION 2. Amendment.** Sub-section B and Sub-section C,
7. is hereby inserted to read as follows:
8. "Sub-section B. Newly appointed employee may
9. not take annual leave during their period
10. of probation. Upon completion of the period
11. of probation, the employee is entitled to
12. leave on a pro-rated basis to the end of
13. the fiscal year".
14. "Sub-section C. Leave must be approved in
15. advanced by the Mayor or the Chairman of
16. the Council. The employee shall file a
17. leave request form with the Mayor or the

18. Chairman of the Council at least twenty four  
19. (24) hours before leave to begin".

20. **SECTION 3. Effective Date:** This Act takes effect upon
