- 1. SECTION 1. Purpose and Intent: That a new clause under

- 6. The office hours of LTG shall be determined by the Mayor
- 7. but not less than 32 hours per week. Hourly wage is
- 8. determined by 32 hours or 64 hours bi-weekly. Business hour
- 9. is from 08:00 a.m to 03:00 p.m from Monday to Thursday &
- 10. 08:00 a.m to 02:30 p.m. on Friday, with a 30 minute lunch
- 11. break for each employee for each working day.
- 12. SECTION 2. Effective Date: This Act shall become effective
- 13. upon signature of the Mayor or upon its approval without
