A BILL FOR AN ACT

To appropriate the sum of \$2,450.00 from the Lelu Town Treasury for the purpose of supplementing the COW Meeting allowance and for other purposes.

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL

1. **SECTION 1. Purpose and Intend.** The purpose and Intend of
2. this Act is clearly stated in its tittle.

3. **SECTION 2. Appropriation.** The sum of \$2,450.00 is hereby
4. authorized and appropriated from the Lelu Town Treasury
5. to supplementing the COW Meeting allowance ending
6. Fiscal Year 2022.

7. **SECTION 3. Apportionment.** The sum appropriated by this Act
8. shall be apportioned as follows:

9. COW Meeting \$2,450.00

10. **SECTION 4. Management:** The sum appropriated by this Act
11. shall be managed and administered by the Chairman of the
12. Council and shall be accounted for in accordance with the
13. Lelu Town Ordinances and applicable rules. The Chairman
14. of the Council shall be responsible for ensuring the sum
15. appropriated is used solely for the purpose for which is
16. appropriated and that no obligations are incurred in excess
17. of this appropriation.

18. **SECTION 5. Lapse Date:** The sum authorized and appropriated
19. by this Act shall be lapsed on September 30th 2022 and all
20. remaining amount shall be backed into the Lelu Town
21. Treasury.

23. **SECTION 6. Effective Date:** This act shall become effective
24. upon approval by the Mayor or upon its becoming an
25. ordinance without signature.






