# BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose: The purpose and intent of this act

- 10. a. Consumable \$3,000.00
- 11. SECTION 4. Management: The sum appropriated by this
- 12. act shall be managed and administered by the Mayor and
