To re-amend LTO:11-24 as amended by LTO:11-45 by amending section 1 and 4 thereof, to change the lapse date and for other purposes.

## BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

- 1. SECTION 1. Appropriation. The sum of \$10,000.00 is hereby
- 2. appropriated from the Lelu Town Treasury to cover all costs
- 3. related to the establishment of a local trading center for
- 4. the people of Lelu for the Fiscal Year ending September
- 5. 2022.
- 6. SECTION 2. Apportionment: The sum appropriated by this Act
- 7. shall by apportioned as follows:
- 8. a. Contractual Services \$3,500.00
- 9. b. Contingencies \$3,500.00
- 10. c. All Others \$3,000.00
- 11. SECTION 3. Management: The sum appropriated by this Act
- 12. shall be managed and administered by the Mayor of Lelu
- 13. and shall be accounted for in accordance with the Lelu
- 14. Town Ordinance and applicable laws. The Mayor shall be
- 15. responsible for ensuring the amount appropriated is used
- 16. for the purpose for which appropriated and that no
- 17. obligations are incurred in excess for the appropriation.
