A BILL FOR AN ACT

To authorize and appropriate the sum of Nine Hundred Ninety Eight Dollars and Thirty One Cents (\$998.31) from the Lelu Town General Treasury to supplement LTO:11-49 and for other purposes.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose:** The purpose and intend of this
2. Act is stated clearly in its title.
3. **SECTION 2. Appropriation:** The sum of \$998.31 is
4. hereby authorized and appropriated to pay of all
5. landing fees and additional costs of two dump
6. trucks purchased for the Lelu Town Government.
7. **SECTION 3. Apportionment:** The sum appropriated by
8. this Act shall be apportioned as follows:
 9. a) FSM Revenue Office \$883.20
 10. b) Kosrae Terminal & Stevedoring Co. \$82.00
 11. c) Kosrae Port Authority \$27.11
 12. d) Kosrae State Government \$\$6.00
13. **SECTION 4. Management:** The sum appropriated by this
14. this Act shall be managed and administered by the

15. Mayor and shall be accounted for in accordance with
16. the Lelu Town Ordinances and applicable rules. The
17. Mayor shall be responsible for ensuring the sum
18. appropriated is used solely for the purposes for
19. which is apportioned and that no obligations are
20. incurred in excess of the appropriation.

21. **SECTION 5. Lapse Date:** The sum authorized and
22. appropriated by this Act shall be lapsed on
23. September 30th, 2021 and all remaining amount shall
24. be transferred back to the General Fund of the Lelu
25. Town Treasury.

26. **SECTION 6. Effective Date:** This Act shall become an
27. ordinance upon the approval by the Mayor or upon
28. it's becoming an ordinance without such signature.




