

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

1. **SECTION 1. Appropriation:** The amount of
2. \$3,000.00 is hereby appropriated from the
3. General Fund of the Lelu Town Treasury for the
4. purpose of compensating part time duties of the
5. Legislative Counsel for the Lelu Town Council.
6. **SECTION 2. Management and Lapse Date:** The sum
7. appropriated by this Act shall be managed and
8. administered by the Mayor and shall be
9. accounted for in accordance with the Lelu Town
10. Ordinance and applicable rules. The Mayor shall
11. be responsible for ensuring that the
12. amount appropriated is used for the purpose
13. for which is appropriated and that no
14. obligations are incurred in excess of sum




