- 3. with "felony" to read as follows:
- 4. Section 11: Separation
- 5. Sub-Section 11.3.Notice
- 6. "In case of medical and unsatisfactory performance, LTG
- 7. shall service Notice of its proposed termination action no
- 8. less than 30 days in advance.
- 9. For reduction in force, notice shall be made no less than
- 10. 60 days.
- 11. Removal because of dishonesty and being convicted of a
- 12. felony, no notice is required.
- 13. SECTION 2. Effective Date: This Act shall become effective
- 14. upon signature of the Mayor or upon its approval without
- 15. such signature.
