BILL FOR AN ACT

To amend Sub-section 11.3 of Section 11 of the Lelu Town Government Manual of Administration by replacing the word "crime" with "felony".

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose and Intent:** To amend sub-section 11.3
2. of Section 11 of the LTG MOA be amended to replace "crime"
3. with "felony" to read as follows:
4. Section 11: Separation
5. Sub-Section 11.3. Notice
6. "In case of medical and unsatisfactory performance, LTG
7. shall service Notice of its proposed termination action no
8. less than 30 days in advance.
9. For reduction in force, notice shall be made no less than
10. 60 days.
11. Removal because of dishonesty and being convicted of a
12. felony, no notice is required.
13. **SECTION 2. Effective Date:** This Act shall become effective
14. upon signature of the Mayor or upon its approval without
15. such signature.


